4. First-aid measures

If sweeping of a contaminated area is necessary use a dust suppressant agent which does not react with the product. Collect dust using a vacuum cleaner equipped with HEPA filter. Small Dry Spills: With clean shovel place material into clean, dry container and cover loosely; move containers from spill area.
