4. First-aid measures

Methods and materials for containment and cleaning up

DO NOT CLEAN-UP OR DISPOSE OF, EXCEPT UNDER SUPERVISION OF A SPECIALIST. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep combustibles (wood, paper, oil, etc.) away from spilled material. Ventilate the contaminated area. This product is miscible in water. Should not be released into the environment.

Large Spills: Stop leak if you can do so without risk. Prevent entry into waterways, sewer, basements or confined areas. Dike the spilled material, where this is possible. Dilute with water. Neutralize with lime or soda ash. Flush to sewer if local regulations permit. Clean up in accordance with all applicable regulations. Following product recovery, flush area with water.

Small Spills: Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal. Clean surface thoroughly to remove residual contamination.
