## 4. First-aid measures

<b>Inhalation</b>	Remove victim to fresh air and keep at rest in a position comfortable for breathing. Call a POISON CENTER or doctor/physician if you feel unwell.
<b>Skin contact</b>	IF ON CLOTHING: rinse immediately contaminated clothing and skin with plenty of water before removing clothes. Wash off with soap and water. Get medical attention if irritation develops and persists.

## 5. Fire-fighting measures

<b>Suitable extinguishing media</b>	Water fog. Foam. Dry chemical powder. Carbon dioxide (CO <sub>2</sub> ).
<b>Unsuitable extinguishing media</b>	Do not use water jet as an extinguisher, as this will spread the fire.

## 6. Accidental release measures

Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation. <b>Methods and materials for containment and cleaning up</b>	Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep combustibles (wood, paper, oil, etc.) away from spilled material. Ventilate the contaminated area. Stop the flow of material, if this is without risk.  Large Spills: Wet down with water and dike for later disposal. Shovel the material into waste container. Minimize dust generation and accumulation. Prevent entry into waterways, sewer, basements or confined areas. Following product recovery, flush area with water.  Small Spills: Sweep up or vacuum up spillage and collect in suitable container for disposal.  Never return spills to original containers for re-use. For waste disposal, see section 13 of the SDS. Wear appropriate protective equipment and clothing during clean-up.
<b>Environmental precautions</b>	Avoid discharge into drains, water courses or onto the ground.

## 7. Handling and storage
